

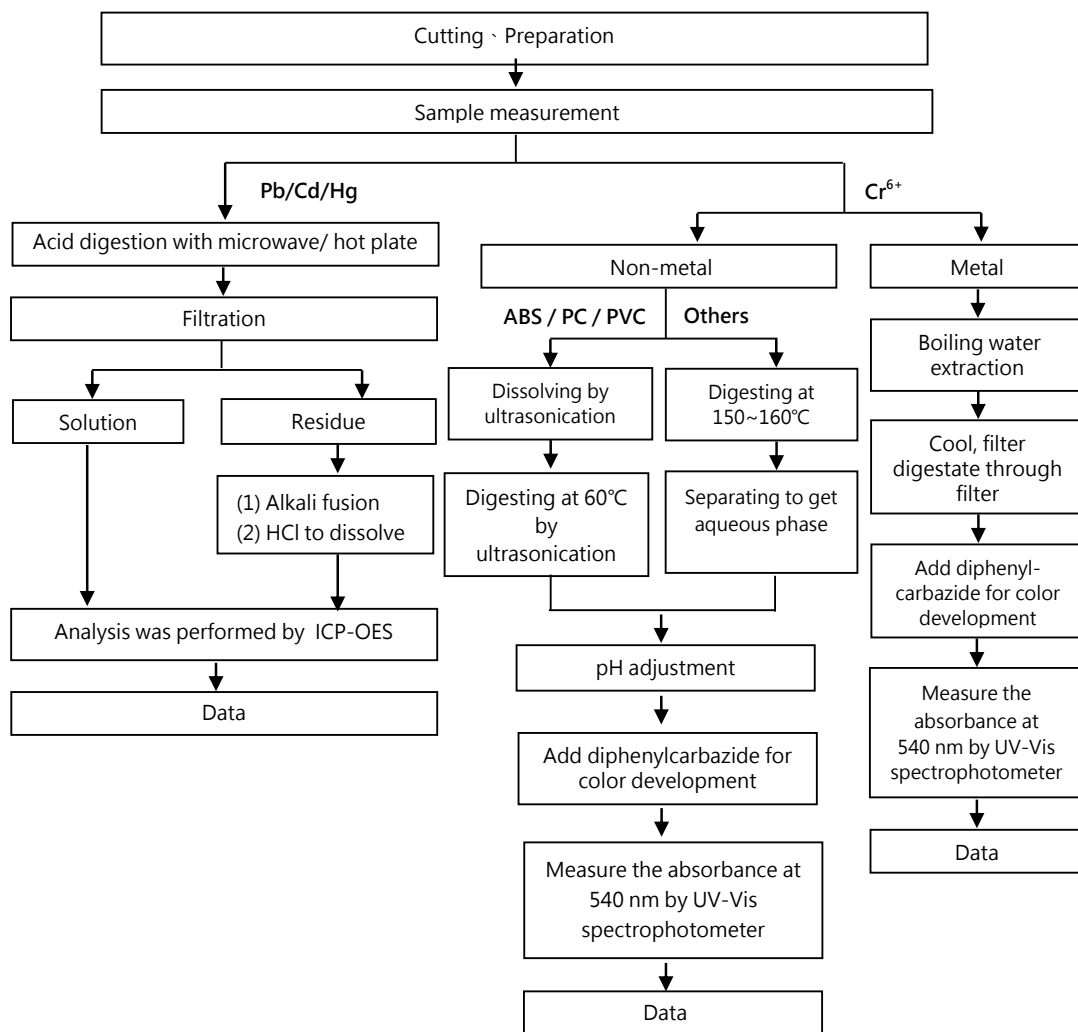

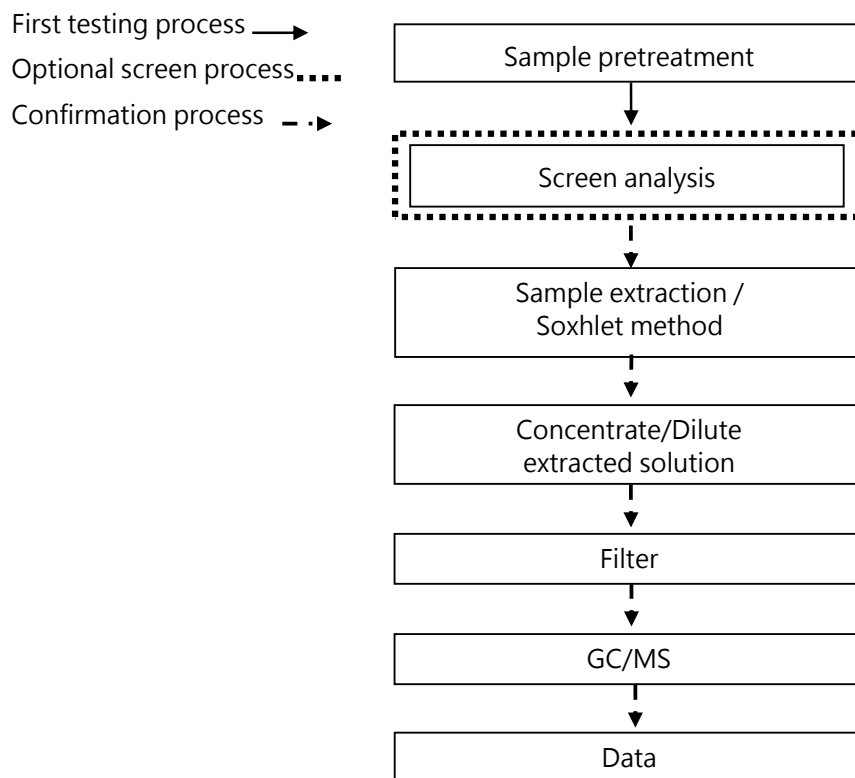
Analytical flow chart of heavy metal

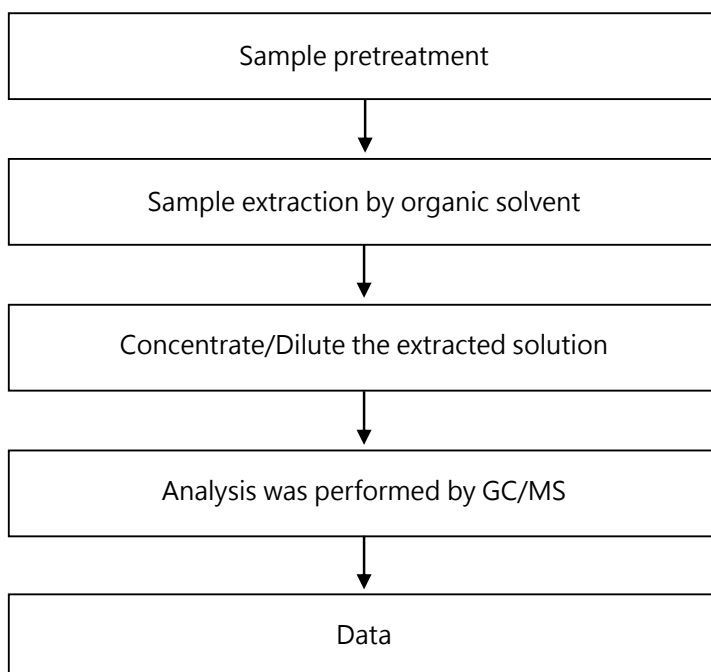

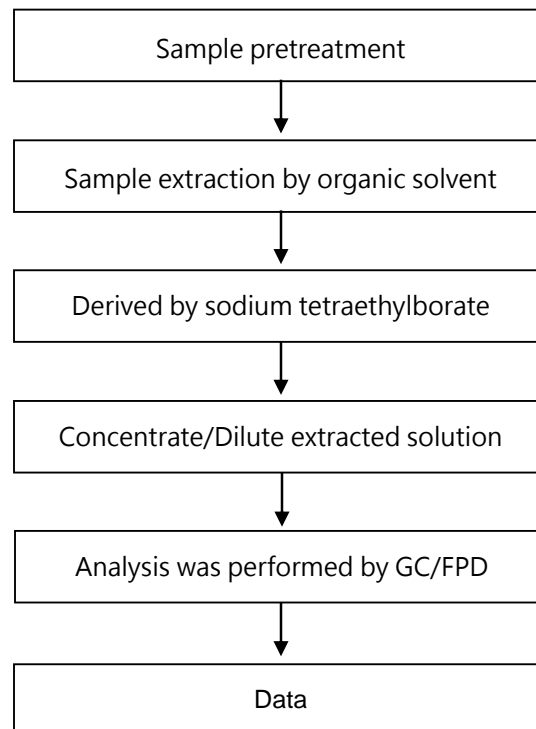

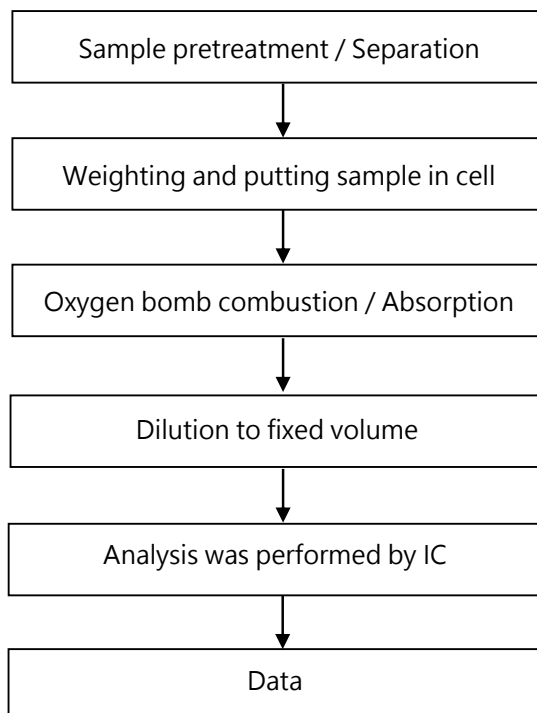

Analytical flow chart - Halogen

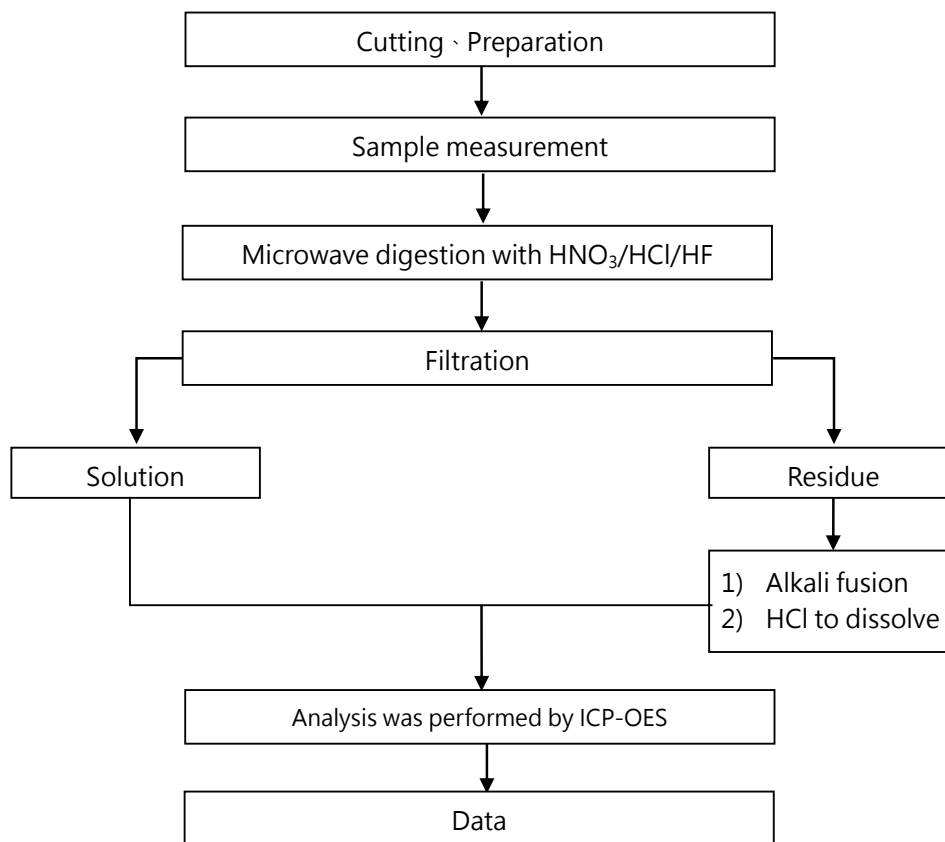

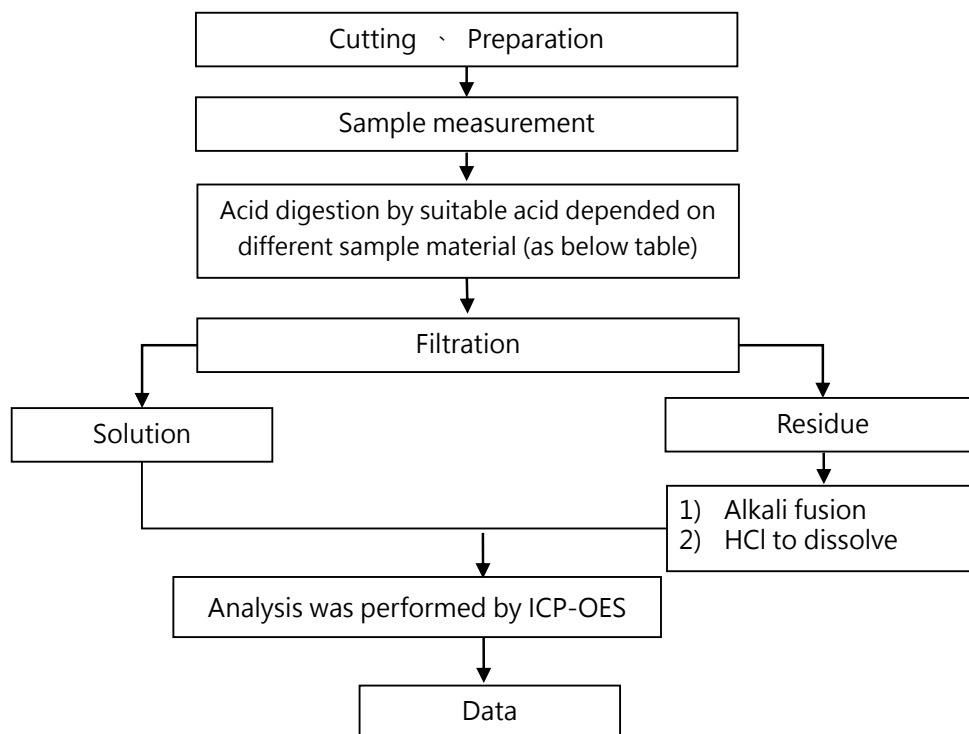

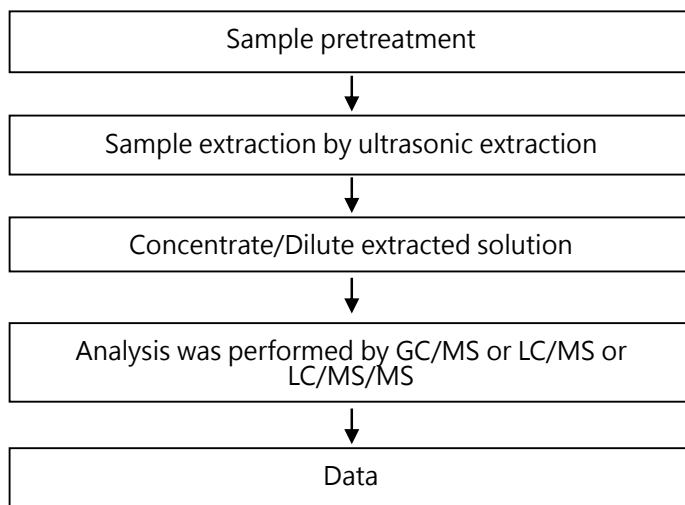

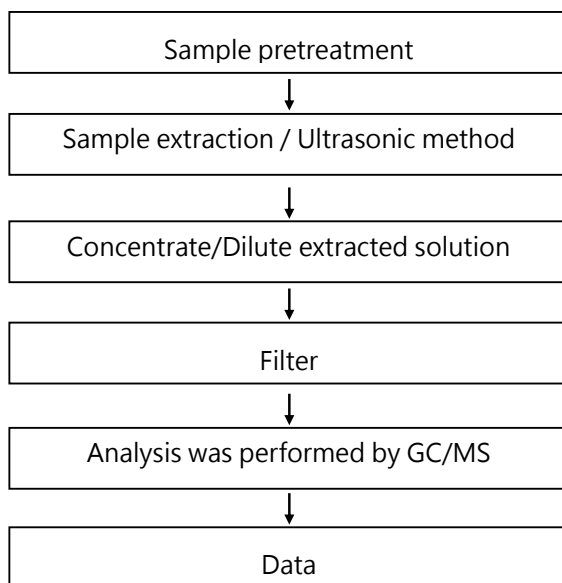

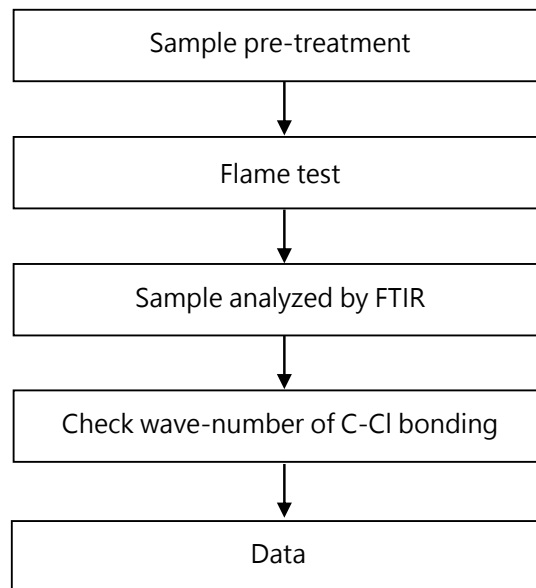

Analysis flow chart - PVC



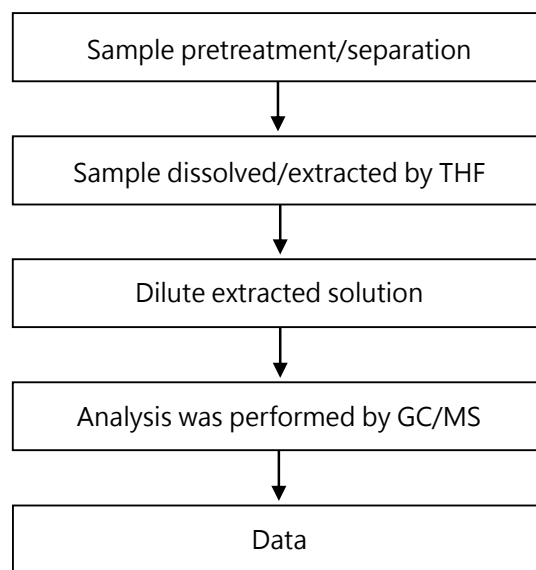

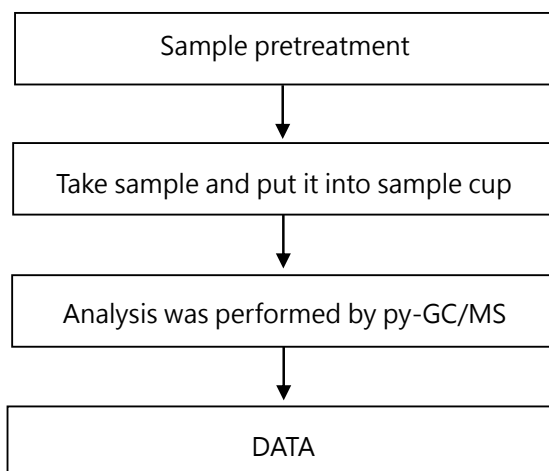

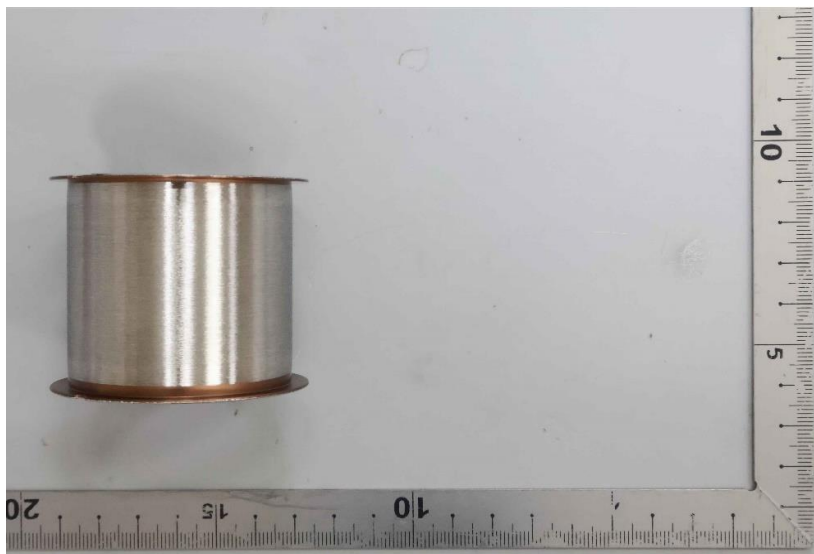
